

## MOBILE HOME RENTAL TERMS AND CONDITIONS

Rental is on a weekly basis and animals are not allowed in the mobile homes. A parking space is provided for one vehicle. A full inventory of kitchen equipment, garden furniture and bedding is provided, with the exception of sheets and pillow cases. All visitors to the camp-site must respect the rules, and check-in on arrival is obligatory. Access will automatically be refused to any persons exceeding the maximum number allowed in the mobile homes. Visitors must provide proof of current civil liability insurance. No additional installations may be erected on the plot.

Reservation will take effect from the date of receipt of the attached form, duly completed and signed, together with a deposit of 25% of the total rental figure which may be paid by means of a cheque drawn on a French bank account, a bank transfer or credit card. The reservation is confirmed on reception of 55% of the total figure due six weeks prior to your arrival. Upon arrival the balance of 20% must be paid either in cash, by means of a French credit card. If you wish to prolong your visit, this will depend on availability of accommodation, and the extra days will be payable at the end of the visit. We regret no refunds will be available in the event of late arrival or early departure. On arrival, a deposit of 150 euros is payable per plot reserved. This sum will be reimbursed on your departure after deduction of any sums which may be due for loss or damage of goods. 75 euros will be retained in the event that the mobile home is not cleaned before your departure. Hand-over of keys and an inventory will be taken simultaneously between 08.30 and 10.00 hours. In the event of written cancellation not less than six weeks before your visit, we will refund your deposit, but will deduct 100 euros for paperwork. In the event of cancellation less than six weeks before your due date for arrival, you will lose the full amount of your deposit. If you are late arriving, we will keep your reservation open for 24 hours from the due date for arrival. After this period, unless we have heard from you, the reservation will be cancelled. Evidently, in the event of late arrival, no deductions can be made for time lost.

Please note: a visitors' tax of 0.55 € per day per person aged over 13 is imposed (2009).

### RESERVATION OF A PLOT:

The reservation will only become effective after reception of the present reservation form duly completed and signed, together with payment of the deposit of 150 euros by means of a cheque drawn on a French bank account, a bank transfer or a credit card. On receipt of the above, a letter of confirmation will be sent to you, and which you should bring with you for presentation at the Reception desk on your arrival. We do not make reservations for periods of less than 10 days. The balance for the period due must be paid in full either in cash or by means of a French credit card, on arrival at the camp site. Possible additional days will be payable at the end of your visit, and are subject to availability. No refund will be forthcoming in the event of early departure.

In the event of written cancellation of your reservation more than 1 month prior to the arrival date, the deposit will be returned after deduction of 25 euros for office expenses. In the event of cancellation less than one month prior to the arrival date, the whole of the deposit will be retained by the Management. In the event of late arrival, the plot will remain reserved for a period of 24 hours from the due date.

After this period and without further notice on the part of the Management, the reservation will be cancelled. It is tacitly agreed that in the event of late arrival, the date indicated on the present form will apply for invoicing.

### **Guarantee details in the event of cancellation or interruption of a holiday**

The costs of cancellation of a reservation are guaranteed in the event that the insured, his/her spouse or his/her direct next of kin (1°) is a victim of one of the following events:

- A motoring accident involving a motor vehicle of less than 3.5 tons, which immobilises the vehicle for a period of more than 48 hours and requires more than 5 hours repair, and which was to be used on holiday, on condition that the accident occurs the day before or on the reservation date.
- Theft of a motor vehicle of less than 3.5 tons occurring during the 30 days preceding departure on holiday or on the projected arrival date, on condition that the vehicle is not found during this period, or is found damaged the day before the departure date which immobilises the vehicle for a period of more than 48 hours and requires more than 5 hours repair.
- Destruction of the insured's home either by fire, explosion or flood damage, on condition that the property is at least 50% damaged.
- Theft at the insured's home within 48 hours of departure on condition that the importance of the claim renders necessary the presence of the insured.
- Theft of identity papers or passports on the date of departure on holiday.
- Death or hospitalisation following illness or accident.
- Complications during pregnancy less than 6 months prior to departure on holiday.
- Transfer or suppression of a holiday by the insured's employer. (excess 20%)
- Relapse or aggravation of a medical condition unsuspected by the insured at the time of reservation.

In each of the cases cited above, the guarantee only comes into effect where total cancellation of the holiday becomes necessary. Guarantee ceiling: 1600.00 Euros
